Proposed Change (if applicable -variation only):Removal of three outdated conditions as we would like to be able to welcome families into the site for meals and allow children to dine with adults. We would also like to use the first and second floors as restaurant space and not just for pre booked functions. Lastly the noise limiter condition was applied before we acquired the site and is no longer relevant as they do not have any music. The only complaints this site has received about noise relate to delivery lorries not music. Conditions to be removed are: 9. No person under fourteen shall be in the bar of the licensed premises during the permitted hours unless one of the following applies: (a) He is the child of the holder of the premises licence. (b) He resides in the premises, but is not employed there. (c) He is in the bar solely for the purpose of passing to or from some part of the premises which is not a bar and to or from which there is no other convenient means of access or egress. (d) The bar is in railway refreshment rooms or other premises constructed, fitted and intended to be used bona fide for any purpose to which the holding of the licence is ancillary. In this condition "bar" includes any place exclusively or mainly used for the consumption of intoxicating liquor. But an area is not a bar when it is usual for it to be, and it is, set apart for the service of table meals and alcohol is only sold or supplied to persons as an ancillary to their table meals. 6. The two function rooms on the first and second floors to be used for pre-booked functions only. 7. A noise limiter to be fitted and operative at all times on all sound systems. The maximum level of such limiter to be set by Westminster City Council Environmental Health Office, to minimalise disturbance to immediate resident neighbours.

Variation: We would like to increase the maximum capacity of people permitted in the premises from its current number of 320 to 500. This is due to the fact that we are becoming an increasingly popular venue, operating a professional theatre (The Marylebone Theatre) as well as classes and workshops in our studio rooms. We propose to install 62 new seats in our theatre so that it reaches a total of 266. Space for the extra seats will be created by reducing the current distance between the rows from 900cm to 800cm. This keeps the distance between seats well within the legal limits. It also ensures safe access to evacuation points in case of fire. Please see attached documents for detailed designs, put together by professional seating company Audise. This is the same company, who installed the original seating in 2020. We would also like to amend the hours for certain licensable activities in our theatre. Specifically: 1. Performance of Live Music: currently we are licensed for only Monday-Saturday. We would like to add in Sundays.
