Proposed Change (if applicable -variation only):The proposed variation is to seek approval of the plans submitted with the application in respect of the changes to the LA03 Premises Licence for the changes approved to the GA05 Casino Premises Licence. The changes are as follows: Ground Floor - The thoroughfare area between Leicester Square and Leicester Street was previously unlicensed, but now becomes licensed. As there is no door or other internal barrier we have extended the licensed area right up to the entrance door from Leicester Street and Leicester Square. Given the 2005 act requirements the door supervisors at both the Leicester Square and Leicester Street entrances should be more than adequate in ensuring the requirements of the 2003 Act are met. Lower Ground Floor - Removal of the large reception desk and new wall openings to improve circulation (including a new ramp for wheelchair access) between the thoroughfare area and the main balcony area. Previously the only way for customers in a wheelchair to access the main area was to use a platform lift. - All new Customer Toilets (including additional Wheelchair Accessible Unisex WC). Basement - Large island bar servery removed and new smaller bar servery formed in the northeast corner. - Dividing screen removed between the main customer area and the Poker Room. - All new Customer Toilets.

Proposed Change (if applicable -variation only):We would like to increase the maximum capacity of people permitted in the premises from its current number of 320 to 500. This is due to the fact that we are becoming an increasingly popular venue, operating a professional theatre (The Marylebone Theatre) as well as classes and workshops in our studio rooms. We propose to install 62 new seats in our theatre so that it reaches a total of 266. Space for the extra seats will be created by reducing the current distance between the rows from 900cm to 800cm. This keeps the distance between seats well within the legal limits. It also ensures safe access to evacuation points in case of fire. Please see attached documents for detailed designs, put together by professional seating company Audise. This is the same company, who installed the original seating in 2020. We would also like to amend the hours for certain licensable activities in our theatre. Specifically: 1. Performance of Plays: currently we are licensed for 12.00-00.00; we would like to change this to 10.00-00.00 to enable us to present children's theatre. 2. Performance of Live Music: currently we are licensed for only Monday-Saturday. We would like to add in Sundays.
