## Licensing Sub-Committee Schedule

Variation: The applicant conducted a pre-application report with Westminster Licensing Authority (REF 24/01220/PREAPM), with proposals suggested applied within this variation. The proposed variation is to amend the current premises layout plans to those in line with those supplied by the applicant. This is an extension into the basement floor to allow the premises to add an additional dining space to the premises. The proposed variation is to also update the premises licence conditions to provide a greater degree of flexibility to the operation of the premises. The site will not add to the Cumulative Impact within Westminster. This application is to reduce hours currently permitted on the premises to be closer to those within Westminster's Core Hour Policy, reducing the potential risk of noise nuisance emanating from the premises and later dispersal of patrons. The operator is adding further conditions to the premises licence including the addition of a Challenge 25 Policy and record of refused sales. The operator is very experienced and already operates within Westminster's CIP without incident. The Premises will operate as a high-end specialist wine bar with food available
